

## DUAL CREDIT - COSMETOLOGY PROGRAM

During this program, students will be taught the rules and regulations of the Texas Department of Licensing and Regulation (TDLR). They will understand the theory and skills of shampooing, hair and scalp treatment, hair cutting, chemical texture services, hair styling and shaping, manicuring, pedicuring, hair coloring, and facials, facial make-up, advanced nail techniques, disorders/diseases of skin scalp and nails, and safety and sanitation skills.

Upon successful completion of our 32 credit hour and 1000 contact hour program, students receive a Certificate of Proficiency from SPC; and will have acquired the knowledge, skills and experiences necessary to sit for the TDLR exam. To qualify for the Certificate of Proficiency, the student must complete a Capstone Experience during the final semester of the program. After students obtain their TDLR licensure, they are able to work as a cosmetologist in an entry-level position in the State of Texas.

**Each semester during high school, beginning with the junior year, dual credit students have the opportunity to complete one course that is part of the first full semester of the cosmetology program:**

### FIRST COLLEGE SEMESTER (4 SEMESTERS/16 CREDIT HOURS OF DUAL CREDIT)

- CSME 1405 - Fundamentals of Cosmetology – Fall of junior year
- CSME 1443 - Manicuring and Related Theory – Spring of junior year
- CSME 1447 - Principles of Skin Care/Facials and Related Theory – Fall of senior year
- CSME 1410 - Introduction to Haircutting and Related Theory – Spring of senior year

**High school graduates may enroll at SPC to finish the next semester of the cosmetology program in order to complete program.**

### SECOND COLLEGE SEMESTER (16 CREDIT HOURS)

- CSME 1453 - Chemical Reformation and Related Theory
- CSME 2401 - Principles of Hair Coloring and Related Theory
- CSME 2439 - Advanced Hair Design
- CSME 2441 - Preparation for the State Licensing Examination

- **Meet with High School Counselor** (each semester).

Students wishing to participate in dual credit should speak with their parent/guardian and high school counselor before enrolling.

Counseling staff will submit an enrollment spreadsheet to SPC each semester with a listing of courses their dual credit students will enroll in for the term.

- **Submit an Unofficial High School Transcript** when the student first applies and a final transcript after high school graduation.
- **Proof of the Meningitis Vaccination** (no older than five years).
