Course Description

This course is a continuation of ENGL 1301 and an intensive study of and practice in the strategies and techniques for developing researched-based expository and persuasive texts, along with being an introduction to literature. The course emphasizes effective and ethical rhetorical inquiry, including primary and secondary research methods; critical reading of a sampling of literary, verbal, visual, and multimedia texts; systematic evaluation, synthesis, and documentation of information sources; and critical thinking about evidence and conclusions.

Prerequisite: Grade of “C” or better in ENGL 1301.

Course Purpose: English 1302 has a two-fold purpose: it encourages critical writing by introducing the students to research and writing from sources, and it introduces the students to the study of literature, including short stories, drama, and poetry.

Core Curriculum Objectives addressed:

- *Communications skills*—to include effective written, oral and visual communication
- *Critical thinking skills*—to include creative thinking, innovation, inquiry, and analysis, evaluation and synthesis of information
- *Teamwork*—to include the ability to consider different points of view and to work effectively with others to support a shared purpose or goal
- *Personal Responsibility*—to include the ability to connect choices, actions, and consequences to ethical decision-making.

Student Learning Outcomes:

Upon successful completion of this course, students will:

- Demonstrate knowledge of individual and collaborative research processes.
- Develop ideas and synthesize primary and secondary sources within focused academic

arguments, including one or more research-based essays.

- Analyze, interpret, and evaluate a variety of texts for the ethical and logical uses of evidence.
- Apply critical thinking to the study of literature and write essays which demonstrate that critical thinking.
- Use edited American English to write in a style that clearly communicates meaning, builds credibility, and inspires belief or action.
- Apply the conventions of style manuals for specific academic disciplines (e.g., APA, CMS, MLA, etc.)
- Read and view videos of works of literature; analyze the use of literary devices (plot, point of view, theme, characterization, setting, symbolism, tone, etc.); participate in class discussions of the readings; and be tested over their understanding of the readings and lectures through quizzes, examinations, and/or written assignments.

Textbook & Supply Requirements

TexBook Program: This course is in the SPC TexBook program, so you do not need to purchase a textbook or access code for this course.

- *What is TexBook?* The required textbook/digital content for this course is available to you in Blackboard from the first day of class. The charge for the textbook/digital content is the lowest price available from the publisher and bookstore and is included in your tuition.
- *How do I access my TexBook?* Your course material is in your Blackboard course from the first day of class. Access to your course material is provided either by VitalSource or other links inside your Blackboard course. VitalSource (and many publisher's) eBook features include the ability to hear the text read aloud, highlight, take notes, create flash cards, see word definitions, build study guides, print select pages, and download 100% of the book for offline access.

General Guidelines for Major Assignments

All major papers should meet the guidelines of the assignment prompt and be properly formatted in MLA 9th edition. You are responsible for understanding and following MLA format and asking questions when needed. Here’s a quick overview: <https://www.scribbr.com/mla/formatting/>

All major assignments should be submitted as *Microsoft Word files (.doc or .docx)*. I cannot accept .gdoc, .pages, .odt, .rtf, or .txt files. I will not accept assignments written in the “Submission Text” or “Comments” portion of the submission link. **Incorrectly submitted files are counted late until the appropriate file type is uploaded.** This is a firm guideline. I cannot stress this enough—do not, for any reason whatsoever, assume that I will accept anything that does not end in .doc or .docx.

Any submission that is blank or corrupt is considered late until properly submitted. Make sure you receive confirmation and a readable preview through Blackboard after submission.

Late Assignment Policy for Major Assignments:

All deadlines are at 11:59 p.m. If you submit after the deadline without a prior authorization for an extension, 20% is automatically deducted from your grade each day until submission. In the event of technical difficulties that prevent you from online submission, email me ASAP (yes, even at 11:58 p.m.) to let me know and attach the assignment. This will ensure your assignment is counted on-time. **I will not, however, grade emailed assignments. You’re expected to upload the final draft appropriately after technical issues are resolved. *Note that this policy only applies to major assignments. Late work is not accepted for any reason on quizzes, activities, exams, or discussions.**

All major writing assignments must be completed in order to pass the course.

Grading Procedure:

Essay grades are returned within two weeks; on average, you can expect them within ten days. I will provide feedback via Blackboard. You are responsible for reading and understanding all grading feedback. You are welcome to ask questions about your grading feedback; however, I ask that you wait at least 24 hours after an assignment has been returned to do so.

Essays submitted with less than half the required word count earn a zero by default.

Research Project

You will be required to complete a multi-part research project over the course of the semester. Over the course of the semester, you will have several steps to complete in service of this project, including:

- *Annotated Bibliography:* You will complete an annotated bibliography related to your project prior to beginning any rough draft. Instructions will be provided. Annotated Bibliographies are worth 10% of your overall course average.
- *Research Paper Outline:* You will complete a detailed, formal outline for your project in Week 13. Instructions will be provided. The outline is worth 5% of your overall course grade.
- *Research Paper Rough Draft:* You will complete and submit a completed first draft of your research project through Packback Deep Dives worth 5% of your overall course grade.
- *Research Paper Peer Review:* You will participate in an extensive review of your peers' rough drafts worth 5% of your course grade.
- *Research Paper:* The most significant part of your research project will be a polished, well-researched essay. This paper will use scholarly sources and should be a minimum of four **full** pages in length. Detailed instructions will be provided. Research papers are worth 20% of your overall course average.

Learning Media & Quizzes

You will complete quizzes, online homework exercises, learning media, and other activities to contribute to your Learning Media & Quizzes score. All these assignments are averaged together for 10% of your course grade. In addition, an important component of this score includes your weekly Literature Study (see below).

Literature Study:

Each week, you will read one or more literary texts for the course. This includes short stories, nonfiction texts, and dramas. It is not possible to pass the course without engaged, active reading each week. For this important part of your learning, you will complete a multi-step learning activity for the week's literature, which are labelled as your Literature Study Assignments.

These run through Perusall, and they will contain a multi-step process including watching videos, reading & annotating a literary text, and completing open-answer quiz questions.

Your scores on Literature Study may be calculated using some or all of the criteria below.

- Contributing thoughtful questions and comments to the class discussion, spread throughout

- the entire reading ([see some examples](#))
- Starting the reading early
- Breaking the reading into chunks (instead of trying to do it all at once)
- Reading all the way to the end of the assigned reading
- Posing thoughtful questions and comments that elicit responses from classmates
- Answering questions from others
- Upvoting thoughtful questions and helpful answers

Packback: Weekly Discussions & Deep Dives

Participation is a requirement for this course, and the Packback Questions platform will be used for online discussion about class topics. Packback Questions is an online community where you can be fearlessly curious and ask open-ended questions to build on top of what we are covering in class and relate topics to real-world applications.

Packback Weekly Discussions Requirements:

Your participation on Packback Weekly Discussions will count toward 15% of your overall course grade. In order to receive full credit, you should submit the following per each deadline period:

- 1 open-ended Question every week by Thursday at 11:59 PM with a minimum Curiosity Score of 50, worth 50pts of each assignment grade
- 2 Responses every week by Sunday at 11:59 PM with a minimum Curiosity Score of 50, worth 50pts of each assignment grade
- Half credit will be provided for questions and responses that do not meet the minimum curiosity score.

Packback Deep Dives

Packback Deep Dives will be used to assess independent research skills and improve academic communication through long-form writing assignments such as essays, papers, and case studies. While completing the summative writing prompts on Deep Dives, you will interact with a Research Assistant that will help you gather your notes and cite your sources, and Digital Writing Assistant for in-the-moment feedback and guidance on your writing.

How to Register on Packback:

Note: Only access Packback through Blackboard in order to ensure your grades sync properly

1. Click “Packback Weekly Discussions” within Blackboard to access the community.
2. Follow the instructions on your screen to finish your registration.
3. In order for your grade to be visible in Blackboard, make sure to only access Packback via Blackboard.

Exams

You will complete two major exams in the course—the midterm and the final. Exams will take place in person during class. No make up exams will be given without written permission **before** the exam date from your instructor.

Extra Credit

Over the course of the semester, you will be presented with optional extra credit opportunities for a possible total of 3 points added to your course average in total. Instructions will be provided.

Blackboard

We will also use Blackboard in this course. You may access the Blackboard login page at southplainscollege.blackboard.com. Do not—under any circumstances—give your username and/or password to anyone else or allow anyone else to log in to your Blackboard account. Doing so will be viewed as academic dishonesty and will be treated as such.

sexuality, or drug use. You should be prepared to handle these things with maturity as a student enrolled in a college-level literature course. If you are sensitive to mentions of suicide or sexual abuse, you should reach out to me early in the semester to discuss specific readings and your options.

Media Disclaimer for Dual Credit Students

If you are using a school-issued device or WiFi connection at your high school, it is possible that some school's content filter may block videos or other media from outside Blackboard. This course is designed for use by SPC students, and I cannot control what any individual school district's content filtering restrictions may be.

In the event that your school's filter blocks course material, some students work around this issue by connecting to a personal hotspot, completing lessons on a mobile device, or completing work at home using their household's device & connection. Any of these solutions are fine with me as long as they are within your school's policies for internet use.
