Course Description: This course is a study of the functions performed in the American system of state governments, with special reference to the development of governance in Texas and its Constitutions. This course satisfies the Legislative requirements for teacher certification.

Course Purpose: Government 2306, as taught at South Plains College, is a reading intensive course designed to acquaint the learner with the origin and development of the Texas Constitution, structure and powers of state and local government, federalism and intergovernmental relations, political participation, the election process, public policy, and the political culture of Texas. This course meets the statutory requirements as set forth by the state of Texas.

Students who have completed this course will:

1. Explain the origin and development of the Texas Constitution.
2. Demonstrate and understanding of state and local political systems and their relationship with the federal government.
3. Describe separation of powers and checks and balances in both theory and practice in Texas.
4. Demonstrate knowledge of the legislative, executive, and judicial branches of Texas Government.
5. Evaluate the role of public opinion, interest groups, and political parties in Texas.
6. Analyze the state and local election process.
7. Describe the rights and responsibilities of citizens.
8. Analyze issues, policies, and political culture of Texas.

4. Personal Responsibility – to include the ability to connect choices, action, and consequences to ethical decision-making by:
 - a. Reading, understanding and affirming agreement and acceptance of principles, guidelines and requirements set forth in the “Statement of Personal Responsibility of Students” (Attached)
 - b. Evaluating choices and actions and relating consequences to personal decision-making
 - c. Accepting personal responsibility for decisions and actions taken or not taken

This course will focus on Texas in the federal system, the Texas Constitution, voting and elections, political parties, the Texas legislature, the Texas governor and the executive branch, the Texas judiciary, law and due process, public policy, and local government.

Course Resources

TexBook Program: *This course is in the SPC TexBook program, so you do not need to purchase a textbook or access code for this course.*

- **What is TexBook?** The required textbook/digital content for this course is available to you in Blackboard from the first day of class. The charge for the textbook/digital content is the lowest price available from the publisher and bookstore and is included in your tuition.
- **How do I access my TexBook?** Your course material is in your Blackboard course from the first day of class. Access to your course material is provided either by VitalSource or other links inside your Blackboard course. VitalSource (and many publisher's) ebook features include the ability to hear the text read aloud, highlight, take notes, create flash cards, see word definitions, build study guides, print select pages, and download 100% of the book for offline access.

- **Opting out of TexBook:** Participating in TexBook is not mandatory, and you can choose to opt out. If you drop the class or opt-out before the opt-out deadline, the TexBook fee will be automatically refunded to your SPC account. The opt-out deadline for Fall and Spring is the twelfth class day. Additional Reading Materials: Instructor will provide additional readings from a variety of sources including current event articles. Readings will be made available to students electronically when possible.

Course Structure: This course will include class lectures, videos, discussion threads, supplemental readings, assignments, and tests. All materials, including the class required textbook, will be accessible through Blackboard, or provided in class.

Attendance: This is a hybrid class (part online; part in-person); attendance will be taken for each weekly class. It is in **your best interest** to attend class regularly and on time. Material that will be covered in class goes well beyond the assigned reading, i.e. many questions that will be on exams come exclusively from lectures rather than just the book. If you **DO** miss a class, **you and you alone** are responsible for finding out what you missed from a classmate buddy or from what is posted on Blackboard. I do not repeat lectures in office hours (this does not mean that you cannot zoom with me if you have questions). An absence is defined as failing to attend class, missing 15 or more minutes of class, or leaving class without the instructor's approval. Additionally, a student accrues an absence each time he or she accumulates a total of three late arrivals (i.e. 5+ minutes late). Whenever feasible, students should let the instructor know about expected absences as soon as possible.

Students who have approved absences for athletic or other school approved activities should provide a schedule within the first two weeks. Students who miss classes or exams due to verifiable circumstances such as medical emergencies should provide the documentation to the professor or facilitator as soon as they return to classes.

Students who do not submit the practice discussion by the census date September 14, 2022, will be automatically dropped from the class.

Student Performance: You must maintain your standards throughout the duration of the semester. There will be no extra credit and there will be little time for playing "catch-up." **If you fail three (3) consecutive "in-class" or reading quizzes, you will be dropped from the class with a failing grade with no further warning.** If you repeatedly fail to submit required work on time, you may be dropped from the class at the discretion of the instructor.

GENERAL POLICIES

- ❖ **Behavior:** Students are expected to be considerate of one another as well as of the instructor. If you need guidance, heed the words of the late Justice Antonin Scalia, "I attack ideas. I don't attack people. And some very good people have some very bad ideas. And if you can't separate the two, you gotta get another day job." Conduct that interferes with other students' right to learn will not be tolerated.
- ❖ **Getting help:** Come see me after class or email me if you have a problem with readings, lecture, or assignments. If you are having difficulty of any kind **the earlier you ask for help, the easier the solution to your problem will be.** I cannot help if I am unaware. When emailing, please be sure to include your full name, the course number, and section number in the subject line of your email. Ex. GOVT 2306-602; the course number is 2306, the section number is 602.
- ❖ **Academic Honesty:** Honesty is the expected standard. **Plagiarism and cheating (copying answers from an outside source or another student) will not be tolerated and can be grounds for dismissal from South Plains College.** Incidents of cheating on examinations will result in failure of the course and potential consequences such as dismissal from South Plains College.

A student is clear to return to class without further assessment from DeEtte Edens, BSN, RN if they have completed the 5-day isolation period, symptoms have improved, and they are without fever for 24 hours without the use of fever-reducing medication. 
You earn your grade; that grade is entered. Grades are updated biweekly (sometimes sooner if there is less reading involved).

- ❖ **Quizzes:** The instructor will administer 12-13 (may drop a quiz) reading quizzes. Should a student miss a reading quiz they will be required to submit outlined reading notes for the chapters covered.
- ❖ **Discussions:** There will be 8 discussion thread assignments in this class. These assignments are designed to expand student interaction and relate to current events. Students will be expected to respond to prompts with one initial response of 500 words (two sources outside of video are required) and respond to two different student posts with at least 150 words. Please read the handouts on discussions located in the classroom BlackBoard. It is highly recommended that students complete work offline in order to save and then copy and paste to the discussion board (you may not attach files). Students must complete an initial post before they can read other posts. Blank submissions are given an automatic zero. Late discussion posts will receive an automatic deduction of 10 points each day they are late. No discussion will be accepted five days after their due date.
- ❖ **Assignments:** There will be a reasonable amount of assignments to supplement student knowledge and understanding. The amount of assignments will be added to this tentative schedule as the semester starts. Assignments have a greater weight than a single quiz or discussion. It would be best not to attempt to offset a zero. Late assignments will receive an automatic deduction of ten points each day they are late. No assignment will be accepted 5 days after their due date.
- ❖ **Exams:** There will be four Unit exams (including the final exam). These exams account for 35% of your overall grade. The final exam will not be cumulative. Exams will consist of multiple-choice and short-answers.
- ❖ **Make-up Exam Policy:** Make-up exams will be allowed with prior notification, but may require documentation. Students wishing to take a make-up exam must apply to the instructor via email. **There are no make-ups for the FINAL EXAM**
